

# New Zealand Oil Spill Control Agent Notices

Last updated: 24 June 2021

## About this list

These notices provide information on the latest decisions and/or proposed changes to the approval of New Zealand Oil Spill Control Agents (NZOSCA).

The four different notice types are:

1. Approvals - provides key information about a product after the decision to approve as a NZOSCA
2. Withdrawal proposals - provides information about the proposal to withdraw approval as a NZOSCA, allowing 10 days for submissions
3. Withdrawal decisions - the final decision, considering any submissions made, to withdraw approval as a NZOSCA
4. Approval amendments - provides information about amendments to conditions or approval of a NZOSCA.
5. Amendments to register information - provides information about amendments to information in the NZOSCA register.

### Note:

The 2016 Part 132 requires Notices to be published to the website, and the NZOSCA register to be updated. Previously, decisions on approval or withdrawal of approval were required to be published as a gazette notice.

Notices are required under MPR 132.63(2a) for approval; MPR 132.68(3a) for proposing the withdrawal of an approval; MPR 130.68(6a) for the decision to withdraw an approval; or, MPR 132.70(2a) for imposing any condition or requirement or otherwise amending an approval.

These 2016 Part 132 Notices do not contain information on the transition of substances (dispersants or demulsifiers) approved under the previous version of the rule, that are deemed approved as NZOSCA's (MPR 132.100).

## 3. Withdrawal decisions

### 06 April 2018
